As per the recall, you are required to immediately quarantine any Alcohol Prep Pads manufactured by Triad Group and any First Aid Kits that contain these Alcohol Prep Pads. If you purchased Alcohol Prep Pads from North by Honeywell, you will be required to return them to us. If you purchased these products as part of a First Aid Kit you may return the complete kit if its security seal has not been removed (plastic shrink wrap) otherwise you are required to return only the recalled prep pad.

If you are in possession of recalled product, please contact our Customer Service Department at 1-877-326-5136, Monday through

Friday between 8:00 AM and 6:30 PM EST to obtain a returned goods authorization and directions on where to return the recalled product.

Additionally, if you have resold any of these products to anyone else, please notify them of this recall and provide them a copy of this notification as well as the original Triad Group notice. **Note that North Safety Products will accept recalled product only from the distributor that purchased the product. End users should be directed to return the product back to the distributor they purchased the product from.**

We will work to replace all returned products with appropriate replacement products as soon as possible.

Moving forward, we will be replacing Alcohol Prep Pads in new First Aid Kits with PVP Prep Pads as a temporary substitution. PVP Prep Pads provide the same wound prep qualities as alcohol.

As we learn more about this recall, we will continue to update you with additional information.
