Replacement of existing products for distributors:

1. Honeywell will accept and rework returned sealed first kits with prep pads over the next few weeks. Unitized kits will be reworked with PVP prep pads until unitized alcohol prep pads are available. All other kits shall be reworked with alcohol prep pads. Expired kits of any kind will not be accepted for rework.

2. End user customers with 300 prep pads or less may complete the "notice of destruction", found at the Honeywell URL Link:

End user customers with greater than 300 prep pads should arrange for an RMA (Return

Merchandise Authorization) for return of the affected product from their distributor.
